sec. 14-62. exclusive use of public highways by unlicensed motor vehicle repair facilities. any person shall not use or operate any motor vehicle as a part of an unlicensed motor vehicle repair facility except under the following conditions: (a) a licensed body shop technician employed by a person required for the performance of non-emergency repairs of motor vehicle components in any person's motor vehicle may use or operate said motor vehicle as a part of an unlicensed motor vehicle repair facility when the license for such licensed body shop technician is in good standing and when the repair or restoration of the vehicle's body or component is to be performed on premises located within such person's place of business. (f) nothing in the provisions of this section shall be construed to prohibit, nor shall the commissioner issue any regulation, limitation or requirement that extends the date by which a motor vehicle, vehicle registration certificate or operator's license may be renewed or reinstated or extended beyond the period otherwise authorized by this section. such motor vehicle, vehicle registration certificate or operator's license may be renewed or reinstated or its period extended at any time upon application thereof by such person. (g) if any person whose license has been revoked pursuant to subparagraph (c) of subdivision (3) of subsection (c) of section 14-227m or subdivision (c) of subsection (3) of subdivision (b) of

said section has in the past violated the provisions of sections 14-227a, 14-227b or 14-227c, the commissioner may recommend that any person who has filed a request for hearing pursuant to paragraph (2) of subsection (a) of this section within one year prior to his or her revocation may be disqualified from requesting a hearing pursuant to said paragraph (2) of subsection (a) of this section until two years have elapsed from the expiration of the period of revocation pursuant to subparagraph (c) of subdivision (3) of subsection (c) of section 14-227m or subdivision (c) of subsection (3) of subdivision (b) of section 14-227m.

sec. 14-11d. driver's retraining program for persons with disabilities. (a) the commissioner of motor vehicles may require any motor vehicle operator who is twenty-four years of age or less, who has been convicted of a violation of any statute relating to motor vehicles, or who has failed to appear for any scheduled court appearance, or who has failed to submit a plea of not guilty by the answer date, or who has not paid the full amount of any fine or additional fee required by law, to attend a motor vehicle operator's retraining program. the commissioner may require any motor vehicle operator over twenty-four years of age, who has been convicted of a violation of any statute relating to motor vehicles or a moving violation, or any suspension violation, or a combination of said violations, committed on two or more occasions, to attend a motor vehicle operator's retraining program. the commissioner may require any motor vehicle operator convicted of traveling more than seventy-five miles per hour in a highway work zone, or any person operating a commercial motor vehicle convicted of traveling more than sixty-five miles per hour in a highway work zone, or any person convicted of a violation of subdivision (1) of subsection (c) of section 14-224, to attend a motor vehicle operator's retraining program. the commissioner shall notify such operator, in writing, of such requirement. a fee of not more than eighty-five dollars shall be charged for the retraining program. the commissioner, after notice and opportunity for hearing, may suspend the motor vehicle operator's license of any such operator who fails to attend or successfully complete the program until the operator successfully completes the program. the hearing shall be limited to any claim of impossibility of the operator to attend the retraining program, or to a determination of mistake or misidentification. the commissioner of motor vehicles may require any motor vehicle operator who is twenty-four years of age or less, who has been convicted of a violation of any general statute relating to motor vehicles or a suspension violation, or a combination of said violations, committed on two or more occasions, to attend a motor vehicle operator's retraining program. the commissioner may require any motor vehicle operator over twenty-four years of age, who has been convicted of a violation of any statute relating to motor vehicles or a suspension violation, or a combination of said violations,

committed on three or more occasions, to attend a motor vehicle operator's retraining program. the commissioner shall notify such operator, in writing, of any such requirement.
